**SOFTWARE END USER LICENSE AGREEMENT**  
**FOR “BF2Hub” APPLICATION AND RELATED SERVICES**

This End User License Agreement (“License”) is an agreement between you and BF2Hub Systems, [www.bf2hub.com](http://www.bf2hub.com), David Szammer (1100 Vienna, Austria), its subsidiaries and affiliates (together, "BF2Hub"). This License governs your use of this application and all related software, documentation, and updates and upgrades that replace or supplement the application and are not distributed with a separate license (together, the “Application”). This Application is licensed to you free of charge. You do not own the Application.

By installing or using the Application, you consent to be bound by this License. Sections 1.C and 2 below describe the data BF2Hub collect and use in the course of providing services and support to you in connection with the Application and BF2Hub. If you do not agree to any portion of this License, do not install or use the Application.

**1. License Grant and Terms of Use.**

- A. **Grant.** BF2Hub grants you a personal, limited, non-exclusive license to install and use the Application for your personal, noncommercial use solely as set forth in this License and any accompanying documentation. Your acquired rights are subject to your compliance with this License. Any commercial use is prohibited. You are expressly prohibited from sublicensing, renting, leasing or otherwise distributing the Application or rights to use the Application. The term of your license shall commence on the date that you start to download, install or otherwise use the Application, and shall end on the earlier of the date that you dispose of the Application; or BF2Hub's termination of this License.
- B. **Copies.** You may download this Application from an authorized source. The number of copies that you can download during a consecutive period of days may be limited. You may not make a copy of the Application available on a network where it could be used by multiple users at the same time. You may not make the Application available over a network where it could be downloaded by multiple users.
- C. **License Validation.** The Application and an internet connection are required for updates or products distributed by BF2Hub. You acknowledge and agree that the Application can automatically validate license rights for some or all updates or products accessed via the Application without separate notice to you. This means that in order to use the Application and certain updates or products, you may have to leave the Application installed on your computer. You acknowledge and agree that the Application may use information regarding your computer, hardware, and operating system to create an anonymous machine

identifier for purposes of updating the Application. Information accessed for this purpose is not stored in retrievable form. You acknowledge and agree that the Application collects, copies and transfers your essential Battlefield2 data, namely your registered GameSpy accounts with their associated login credentials, CD- and/or DVD-Keys, player statistics and all local Battlefield2 profile settings (together, the "BF2-Data") in retrievable form to storage environment owned by BF2Hub. The Application stores this BF2-Data to provide authorized access by BF2Hub updates, products and services limited to the BF2-Data account owner only. If you do not agree to this collection and use of BF2-Data, do not install or use the Application. You acknowledge and agree that the Application may modify certain files on your operating system for purposes of redirecting Battlefield2 network requests to the BF2Hub network. If you do not agree to those file modifications or network request redirects, do not install or use the Application.

- D. **Application Updates.** You agree that the Application may automatically download and install updates, upgrades and additional features that BF2Hub deems reasonable, beneficial to you and/or reasonably necessary. You acknowledge and agree that any obligation BF2Hub may have to support the previous version(s) may be ended upon the availability of the update, upgrade and/or implementation of additional features. This License shall apply to any updates, upgrades and/or additional features that are not distributed with a separate license or other agreement.
- E. **Reservation of Rights and Restrictions.** The Application is licensed, and not sold, to you for use only under the terms of this License. Except as expressly licensed to you herein, BF2Hub reserves all right, title and interest in the Application and all software delivered through the Application (including all characters, storyline, images, photographs, animations, video, music, text), and all associated copyrights, trademarks, and other intellectual property rights therein. The License is limited to the intellectual property rights of BF2Hub and its licensors in the Application and does not include any rights to other patents or intellectual property. Except, and only to the extent that may be permitted under applicable law, you may not decompile, disassemble, or reverse engineer the Application by any means whatsoever, or alter, modify, enhance, or create a derivative work of the Application. You may not remove, alter, or obscure any product identification, copyright, or other intellectual property notices in the Application or software delivered through the Application.
- F. **Installation and Un-installation.** Un-installation of the Application can be accomplished by removing the files entitled "BF2Hub" or "BF2Hub Client" ("Application Files") via the "Add/Remove Programs" page in the Control Panel. Certain empty cache folders and other Application data may also remain on your machine after un- installation of the Application Files and can be deleted manually. All BF2-Data which is

already transmitted to storage environment owned by BF2Hub will remain until BF2Hub decides to delete this data for any reason.

## **2. Consent to Collection and Use of BF2-Data.**

BF2Hub knows that you care how your BF2-Data is collected and used and we appreciate your trust that we will do so carefully and sensibly. BF2Hub would never sell or share your personally identifiable information to anyone. If you do not agree to the collection and use of the BF2-Data, do not install or use the Application.

The BF2-Data and all other data provided to BF2Hub and/or collected by BF2Hub in connection with your installation and use of this Application is collected, used, stored and transmitted in accordance with BF2Hub's Privacy Policy located at [www.bf2hub.com](http://www.bf2hub.com). To the extent that anything in this section conflicts or is inconsistent with the terms of BF2Hub's Privacy Policy, the terms of the Privacy Policy shall control.

**3. System Interaction.** The following processes may be associated with the Application: **bf2hub.exe, uninstall-bf2hub.exe**. The Application requires machine resources in order to perform.

**4. Auto-Update Feature.** The Application will automatically inform you to download new updates. The Application always asks you for confirmation and will not force you to install an update. Note that by refusing an update the Application is not able to collect, store and transfer your BF2-Data as expected.

**5. Termination.** This License is effective until terminated. Your rights under this License will terminate immediately and automatically without any notice from BF2Hub if (i) you fail to comply with any of the terms and conditions of this License; or (ii) BF2Hub ceases to support the Application. Promptly upon termination, you must cease all use of the Application and destroy all copies of the Application in your possession or control. BF2Hub's termination will not limit any of BF2Hub's other rights or remedies at law or in equity. Sections 2-14 of this License shall survive termination or expiration of this License for any reason.

**6. BF2Hub Application and related services usage limitation.** The BF2Hub Application, products, updates and all other BF2Hub services, such as website or data storage, (together, the "BF2Hub Service") is free of charge. At NO time BF2Hub can guarantee, that the BF2Hub Service works as expected or at all. You acknowledge and agree that the BF2Hub Service is provided "AS IS" without warranty of any kind. BF2Hub reserves the right to discontinue, close or prevent the usage (for you, certain or all users) of the BF2Hub Service for any reason at any time without notification to you or anyone.

11. **Injunctive Relief.** You agree that a breach of this License may cause irreparable injury to BF2Hub for which monetary damages would not be an adequate remedy and BF2Hub shall be entitled to seek equitable relief in addition to any remedies it may have hereunder or at law.

12. **Agreement changes.** BF2Hub may change the "SOFTWARE END USER LICENSE AGREEMENT FOR "BF2Hub" APPLICATION AND RELATED SERVICES" ("EULA") at any time and the changes will become effective 3 days after posting the revised EULA (the "Effective Date"). Exclusive place of jurisdiction is the capitol of Austria, Vienna.

15. **Entire Agreement.** This License constitutes the entire agreement between you and BF2Hub with respect to the Application and supersedes all prior or contemporaneous understandings regarding such subject matter. No amendment to or modification of this License will be binding unless made in writing and signed by BF2Hub. No failure to exercise, and no delay in exercising, on the part of either party, any right or any power hereunder shall operate as a waiver thereof, nor shall any single or partial exercise of any right or power hereunder preclude further exercise of any other right hereunder. In the event of a conflict between this License and any applicable purchase or other terms, the terms of this License shall govern.
